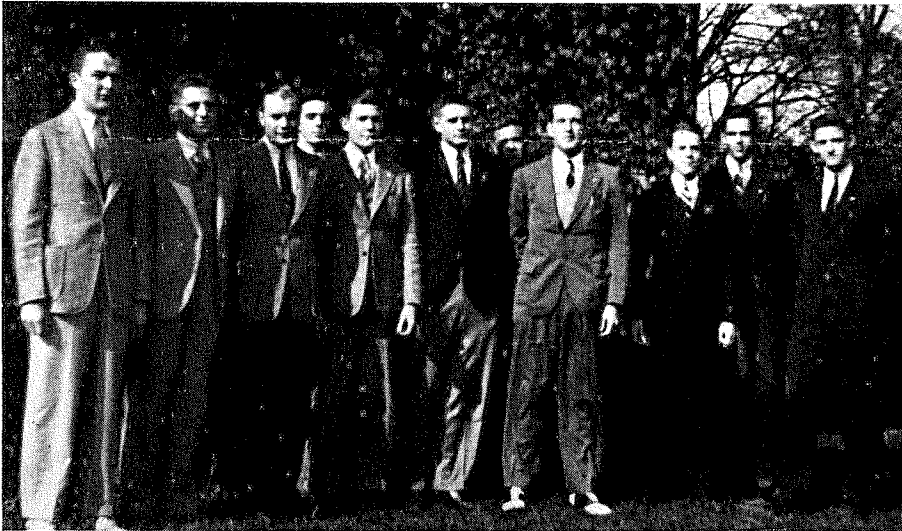

Alpha Delt Mourns Five Alumni Deaths Of Recent Months

BRIGHAM '70, WHO ENTERED CORNELL FIRST YEAR AMONG DECEASED

The chapter has been informed of the deaths of five alumni since the last issue of the Alpha Delt.

D. Johnson Brigham '70, who entered Cornell at its opening, died at his home in Des Moines, Iowa., October 8. He had served as the Iowa State librarian since 1898. He was a charter member of the Cornell chapter.

Won Plaque as Author

Brother Brigham was publisher of the Cedar Rapids, Iowa, Republican from 1881 to 1883; served as American consul in Aix-La-Chapelle, Germany; and for four years was editor and publisher of the Midland Monthly. He was a past president of the Des Moines Chamber of Commerce, the Iowa State Library association, and the National Association of State Libraries. Author of many books, "The Youth of Old Age" won the Iowa Library association plaque in 1934 as the outstanding contribution by an Iowa author.

John Savage, Jr. '78 died September 26, 1935, at his home in Brady, Texas, where he had lived for many years. Information concerning his death reached the chapter only recently.

S. Morgan Barber '90 died October 5 at his home at Green Farms, Conn. He entered the optional course in 1886 and remained for two years.

Lived in India

Donald S. Gray '10 died in August at London, England. For some time he had been with the Standard Oil company at Calcutta, India. During the War he was a captain in the 350th Field artillery. While in Cornell, Brother Gray was active in Undine, Savage Club, Mummy Club, Glee club, and Bench and Board.

Charles T. Lansing '16 died at his home in Englewood, N. J., August 19. Death was caused by heart failure. Brother Lansing was a member of the Knickerbocker and Englewood clubs. He was captain of the golf team his senior year at Cornell.

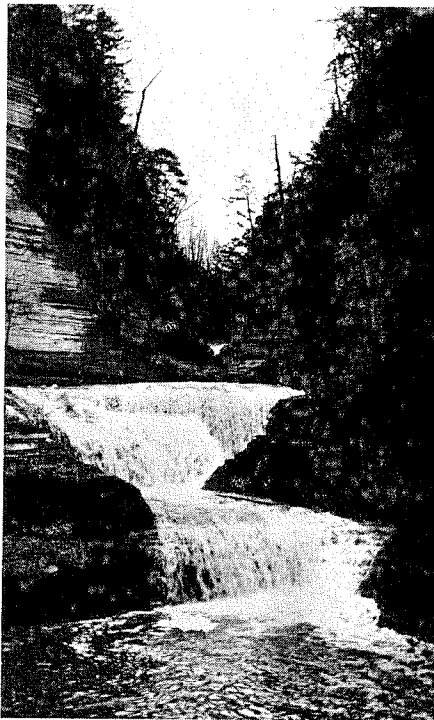

Teagle '00 Enters Harmonica Business With Large Supply

GETS FORTY MILLION GERMAN INSTRUMENTS IN TRADE FOR OIL CARGO

That Walter C. Teagle '00, as head of the Standard Oil company of New Jersey, has recently entered into the music business was revealed in his address to the stockholders of his company at their annual meeting last June.

Forty million harmonicas were acquired by the company in payment for shipments of oil to Germany. This deal, which is one of the strangest in the history of either the oil or the harmonica business, was necessitated, he said, because of the German government's prohibition on the exportation of currency.

As Brother Teagle explained to the astonished stockholders, "We have bought some ships and we have bought some mouth organs. We have enough mouth organs to give two to every boy in the country. So we are also in the music business."

Just what he intended to do with harmonicas, Teagle did not say, but as yet there has been no confirmation of the rumor that he will establish a Harmonica College on the Hill and provide enough instruments for the next hundred years.

Brother Young has had a long and distinguished career of public service, serving in the New York State Assembly from 1905 to 1907, followed by sixteen years as Judge of the New York Municipal Court.
