

The annual Corporation meeting and Trustee's meeting was held at the Chapter house on April 16, 1949. Among the brothers who returned for these meetings were F. J. Tone, Jr., T. H. Booth, Hunt Bradley, James E. Rice, Jr., and F. S. Brown. At the meeting it was announced that the collection of Alumni Dues would be resumed this year after a suspension in lieu of the active chapter's drive for funds to repair the Lodge

Brother J. P. Young was given a vote of appreciation for his generous offer to complete the fill and black top the parking space. A report was given by Chapter President Jim Sliger on the lodge and the plans to date for its being repaired. Brothers L. B. Colt, R. W. Hooker, James R. Thomas and John P. # Convention Expected To Be Largest Ever

## Welcoming Address to be Delivered By Dr. Edmund Day

"C" day is approaching, and the Cornell forces are alerted for the expected mass invasion of Ithaca by the delegates, guests, and alumni. Cornell University's commander-inj-chief, Dr. Edmund E. Day, will brief the legion at zero hour, 1400, on June 23rd, when he welcomes the gathered forces to the Cornell Theater of Operations.

Registrations have been arriving at the Cornell Headquarters fast and furiously from all sections of the country. The response from the alumni forces has been very gratifying, and it appears that the "veterans of the Cornell Chapter" are planning a few extra operations of their own. The chapters have been replying very heavily with advance registrations, indicating that the convention will be one of the largest operations in the history of Alpha Delta Phi conventions. Of course, it will be difficult for the units in the far West and middle

Friday night the gathered forces will proceed by motorcade to Taughannock State Park, located on the shores of famous Lake Cayuga, for the Convention's feature of the day, the picnic. A real old fashioned fraternity gathering has been planned for this occasion with plenty of delicious food and ample supplies of cooling refreshing beverages. For the Brothers who like the call of the wild, many beautiful trails along the shores of the lake will take them to scenic spots among which is Taughannock Falls, the largest waterfall east of the Rockies.

Saturday will bring the business sessions to a close. The official convention picture will be taken immediately after lunch, and the afternoon is free for any type of amusement one wishes. The convention will come to a close on Saturday Evening with the formal cocktail party which will be held
